APPENDIX 2: CALCULATION, SHARING AND PAYMENT OF THE FAIR CUT

In accordance with the terms and conditions of the Meme Commons license, the Fair cut is calculated, shared and paid according to the conditions listed below.

1. The Fair cut for any exploitation of the hereby Licensed Work is a proportional remuneration fixed as follows:

- 11 % (eleven percent) of the Licensee's Net Incomes.

2. The Licensed Work is a derivative Work. Any Subsequent Work shall be considered as a common or composite Work.

3. The Fair cut for any exploitation of a common Work is a proportional remuneration on Licensee's Net Incomes fixed and shared according to the number of derivative Works integrated, according to an evolving scale represented by the following table:

4. The Fair cut for any exploitation of a Composite Work is a proportional remuneration on Licensee's Net Incomes fixed and shared according to the number of integrated Works, according to an evolving scale represented by the following table:

2 - 5	11%	10%

5. Caps of the total percent of all Fair cut cumulated for Common and/or Composite Works are set at 21% (twenty-one percent) of Licensee's Net Incomes.

6. Any author of a Subsequent Work (derivative, common, composite) must apply the same terms and conditions of Fair cut that are set for any copy, distribution, modification, and/or exploitation of the subsequent Work.
